Raffle Rules

Raffles are open to residents of Ohio and other states where permitted. Only individuals who are 18 years or older and legal U.S. citizens may enter. The purchase/donation for a raffle ticket does not constitute a charitable donation and, therefore, any purchase/donation is not deductible as a charitable contribution.

Odds of winning the East Palestine Sportsmen's club Raffle and 50/50 drawings are based on the number of tickets sold for each drawing. The raffle will be drawn once all tickets have been sold at the conclusion of the next scheduled East Palestine Sportsmen's club monthly meeting.

All prizes will be awarded. Each ticket is not eligible to win more than once. (Only one prize per ticket) In the case a prize is declined the prize becomes the property of East Palestine Sportsmen's club.

Guns awarded as prizes will be distributed through a licensed FFL dealer and only in compliance with federal and state laws and applicable local ordinances. If a winner is ineligible to receive a prize under relevant state, federal or local laws and regulations, the prize will be forfeited, and no substitution will be provided. In the instance that a winner is not old enough (21 years of age) to possess a handgun the East Palestine Sportsmen's club shall issue a gift card or check in the amount of the cost of the handgun. This offer is void where prohibited by law, and all federal, state, and local laws and regulations apply. In the event a prize is forfeited or unclaimed the prize becomes the property of East Palestine Sportsmen's club.

Prize winners will be notified by phone, email and, as needed, physical mail. All winners have 30 calendar days to claim their prize. If the winner fails to claim their prize within this period, the prize will be forfeited, and prize becomes the property of East Palestine Sportsmen's club.

The winner by accepting the prize by mail will be required to sign and return an affidavit of eligibility and release of liability/publicity, and any required tax and/or identification documents within 15 business days of notification by mail. If the winner fails to return the required documents within this period, the prize will be forfeited, and prize becomes the property of East Palestine Sportsmen's club.

Any taxes on prizes are the sole responsibility of the winner. FFL transfer fees charged by the winner's designated licensed dealer are the responsibility of the winner. The purchase of tickets constitutes consent for the use of the name and image of the winner by the sponsor. There will be no refunds for tickets purchased. By participating in this raffle, you agree that any claim may be resolved by the sponsor in the form of liquidated damages limited to no more than the cost of the ticket or tickets purchased by the complainant.

Unless otherwise specified, prizes are non-transferable and there will be no prize substitutions. If a prize winner decides to forfeit an item or is ineligible to receive a prize under relevant state, federal or local laws and regulations, no substitution will be provided, the prize will be forfeited, and prize becomes the property of East Palestine Sportsmen's club.
